

## ICMI Contact Center Expo – A Digital Experience \$1,000 Sweepstakes

### OFFICIAL RULES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN.** OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES, DISTRICT OF COLUMBIA AND CANADA, EXCLUDING QUEBEC, THAT HAVE A VALID DRIVER'S LICENSE OR TAX I.D. NUMBER, WHO ARE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. VOID WHERE PROHIBITED. There are two (2) ways to enter during the Entry Period. **Points Entry:** To qualify, you must register and attend ICMI Contact Center Expo: A Digital Experience (the "Event") and earn at least 500 points based on certain activities performed (the "Activities") within the ICMI Contact Center Expo virtual environment. Activities to earn points include a variety of engagement activities with sponsors and attendees as described in detail on the giveaway page. You can register for the Event via [this link](#). **Contact Information Entry:** To qualify for the drawing (the "Drawing"), follow this link and fill out your name, email address and date of birth during the Entry Period.
